Improvements to two existing tank sites to include 1) Young Tank: replace the interior and exterior coatings, install safety railings, climb bar and seismic improvements to overflow; and 2) Our Peak Tank: replace two leaking redwood tanks with two new steel tanks, improve foundations to meet seismic requirements, connect new tanks to existing distribution system. Improvements are necessary to continue reliable water service in RRCWD pressure zones.
