**PROJECT TITLE:** Well 17 Design Project (Project)

**PROJECT LOCATION:** The Project is located on two Linda County Water District-owned parcels at/near the intersection of Linda Avenue and Stonehaven Drive, community of Linda, within Yuba County.

**PROJECT DESCRIPTION:** The State Water Resources Control Board (State Water Board) is a Responsible Agency for the Project. The State Water Board's Drinking Water State Revolving Fund (SRF) Program is financing the Project. The Project includes water system improvements to provide the District with a long-term, safe and reliable water supply. The improvements will include the equipping of an existing well (620-feet deep), a new groundwater treatment facility, and a 1.2-million-gallon storage tank. Additionally, the Project will include an on-site chlorine generation system, a pressure filtration treatment, and a control building that will house electrical and chemical feed equipment. A new pipeline, 16-inch diameter and approximately 1,500-feet long, will connect the well and storage tank sites.

**PUBLIC AGENCY APPROVING PROJECT AND CARRYING OUT PROJECT:** The State Water Board has approved SRF financing for the Project described above on March 15, 2022. The Linda County Water District will be carrying out the Project. The State Water Board has made the following California Environmental Quality Act (CEQA) determinations regarding the Project:

1. The Project will not have a significant effect on the environment. The Project will not have a significant effect on water quality impacts. This determination is limited to effects on water quality under the State Water Board's jurisdiction as a Responsible Agency.
2. A Mitigated Negative Declaration was prepared and adopted/certified for the Project pursuant to the provisions of CEQA.

3. Mitigation measures were made a condition of approval of the Project.
4. A mitigation monitoring and reporting plan/program was adopted for the Project.
