Project Description (Proposed actions, location, and/or consequences).

The project site, identified as Area 44, is an existing residential neighborhood just outside the Modesto City limits. The project area bounded by West Hatch Road, Parkdale Drive, and Carpenter Road. The site is located approximately 2 miles west of State Route 99 and just south of the Tuolumne River, in unincorporated Stanislaus County. Stanislaus County is proposing to install new sanitary sewer, domestic water supply, and storm drain facilities in Area 40 in accordance with City of Ceres standards. The proposed project would additionally install safety improvements throughout the area, including sidewalks, Americans with Disabilities Act (ADA) compliant curb ramps, crosswalks, and street lighting. The project is determined to result in potentially significant impacts to Biological, Cultural, and Tribal Cultural Resources. However, with the incorporation of project-specific mitigation measures, any potentially significant impacts resulting from the project would be reduced to a less than significant level.

**Biological Resources:** Vegetation removal or earthwork shall be minimized during the nesting season (February 1 — August 31). If vegetation removal and/or ground disturbance is required during this period, a pre-construction nesting bird and raptor survey (including the Swainson's hawk) must be conducted within three (3) days prior to commencement of construction activities and will extend 500 feet from the project area. If migratory birds or raptors are found to be nesting in or adjacent to the Project site, a 250-foot no-disturbance buffer shall be established around raptor nests (500-foot for Swainson's hawk) and a 50-foot buffer around non-raptor nests. The buffer shall be maintained until the end of the breeding season or until young have fledged.

**Cultural and Tribal Cultural Resources:** A qualified cultural resources specialist shall be contacted should unrecorded cultural resources be encountered to assess the potential significance of the find. If cultural materials are discovered, all work in the area of the find will be halted and a qualified archaeologist will be notified. The archaeologist will determine significance of the resource per CRHR and develop appropriate mitigation.
