### NOTICE OF INTENT TO ADOPT A MITIGATED NEGATIVE DECLARATION

NOTICE IS HEREBY GIVEN THAT THE DEPARTMENT OF PLANNING, BUILDING & ENVIRONMENTAL SERVICES OF THE COUNTY OF NAPA is considering adoption of a Mitigated Negative Declaration for the project identified below:

**MILLER VINEYARD: VINEYARD CONVERSION – ENVIRONMENTAL REVIEW** of land disturbing activities on slopes greater than 5% associated with Agricultural Erosion Control Plan (ECP) #P22-00153-ECP for the clearing of vegetation, earthmoving, and installation and maintenance of erosion control measures for conversion to vineyard of 7.0 gross acres of new vineyard (i.e., development area, proposed clearing limits; approximately 4.6 new net acres of vines and legalization of 1.0 acres of existing vineyards for a total of 5.6 net acres of vines) of gentle to steeply sloped (13-30% slope, with less than 0.08 acres occurring on slopes over 30%) coast live oak woodland (4.0 acres of 12.8 acres converted), Douglas-fir forest (1.4 acres of 9.8 acres converted), annual grassland (0.6 acres of 3.3 acres converted) and developed (1 acre of 1.8 acres legalized) located within the Napa River – Bale Mill Reach and Dutch Henry Creek watersheds consisting of approximate 28.77-acre parcel (APN: 0, 3906 Silverado Trail).

**LOCATION:** 3906 Silverado Trail North, Calistoga (Assessor's Parcel No. 021-030-006-000). The parcel is accessed off of Silverado Trail (an existing paved road), and the subject property is accessed via a private driveway that provides access to the site. The project site is located approximately 3.25 miles south of the City of Calistoga. The project site is located within the Napa River – Bale Mill Reach and Dutch Henry Creek Drainage watersheds, and within the Agricultural Watershed zoning district.

**CEQA STATUS:** Mitigated Negative Declaration Prepared. According to the proposed Mitigated Negative Declaration, the proposed project would have potentially significant environmental impacts on Biological Resources, if mitigation measures are not included. This project site is not on any of the lists of hazardous waste sites enumerated under CA Government Code Section 65962.5.

The proposed Mitigated Negative Declaration application is available for inspection, along with copies of all documents that relate to the above-described project, between the hours of 8:00 AM. and 4:30 PM Monday through Friday, at the office of the Napa County Planning, Building, & Environmental Services Department, 1195 Third Street, Second Floor, Napa, California. Scheduling appointments to review documents is encouraged. Written comments regarding the environmental effects of this project, the adequacy of the measures identified, and the adequacy of the proposed Mitigated Negative Declaration are solicited. All such comments must be presented during the public review period, which runs from August 8, 2024 through September 7, 2024.

The Director of Planning, Building and Environmental Services will not act on the project during the public review period. Thereafter, the Director will consider all written comments received regarding whether or not the proposed project would have a significant effect on the environment, any written responses prepared, and the adequacy of the final environmental document produced prior to taking action on the project.

An appeal to the decisions of the Director of Planning, Building and Environmental Services regarding this project and the related environmental document must be filed in writing with the Clerk of the Board of Supervisors in the manner required by Napa County Code Chapter 2.88.

**If you challenge these particular proceedings in court, you may be limited to raising only those issues you or someone else raised during the comment period described in this notice.**
