Description of Nature, Purpose and Beneficiaries of Project:

The program of routine maintenance includes, but is not limited to, all mowing, burning, vegetation pruning, fallen or hazardous tree removal, road grading, minor earthwork repairs and the placement of rock revetment on Reclamation District 1500's flood control levees, as well as any other similar activities that are needed to meet standards established by applicable law. Unit 1 The Sacramento River levee and unit 2 the Sutter Bypass levees are part of the federal Sacramento River Flood Control Project and have been turned over to Reclamation District 1500 for operation and maintenance. These levees protect residents, property, infrastructure, Crop Storage facilities. And habitat in the Sutter Basin area. In addition, the District undertakes the operation and maintenance of Canals, Drains and pumping plants in the Sutter Basin area.

**RESOLUTION NO. 2022-02-01 OF THE BOARD OF TRUSTEES
OF RECLAMATION DISTRICT NO. 1500**

Upon motion duly made, and unanimously passed, it was:

RESOLVED, that the work described in the Reclamation District 1500's 2024 Flood Maintenance Program consists of routine levee maintenance to existing levee facilities and to drainage facilities and infrastructure and falls within the categorical exemptions to the California Environmental Quality Act.

RESOLVED FURTHER, that Reclamation District 1500 performs routine maintenance on its existing infrastructure and facilities associated with the district's operations and responsibilities. These routine maintenances of facilities fall within the categorical exemptions of the California Environmental Quality Act.

RESOLVED FURTHER, that all repair of erosion protection, all levee crown restoration, all Levee section restoration including adding material to back slopes, construction of toe berms and construction of seepage berms, drains and other measures to control seepage falls within the categorical exemptions to the California Environmental Quality Act.

RESOLVED FURTHER that all the work described above falls within the categorical exemptions to the California Environmental Quality Act pursuant to Section 15301 (Class I) of the Guidelines for the California Environmental Quality Act, California Administrative Code of Regulations, Title 14, Chapter 3, Article 19.

RESOLVED FURTHER that the district finds the proposed work will not have a significant effect upon the environment.

RESOLVED FURTHER, that said work does not constitute an exception to the exemptions of the California Environmental Quality Act.

RESOLVED FURTHER, that Roger Cornwell General Manager, is hereby directed to prepare and file with the County Clerk of Sutter County for posting, a "Notice of Exemption" pursuant to California Administrative Code of Regulations, Title 14, Chapter 3, Section 15061.
