The Project is proposing to improve and replace an existing water distribution system that currently serves 34 residential connections in the unincorporated area of Orleans. The Project would demolish an existing in-line filtration plant and replace it with a new surface, direct-filtration water treatment plant (WTP). The Project would construct a new water treatment building with a backwash reclaim tank. A proposed generator and propane tank would be located adjacent to the water treatment building. The Project would also demolish an existing redwood raw water tank and replace it with a new bolted steel water storage tank.
