Senate Bill (SB) 375 designates the California Air Resources Board (CARB) as the lead agency in establishing region-specific greenhouse gas (GHG) emission reduction targets (targets) for each metropolitan planning organization (MPO). SB375 mandates that CARB updates the targets every eight years. CARB would consider the latest technical information and any target recommendations provided by MPOs, becoming effective in 2026. The targets update will support achievement of the State's current climate, public health, and air quality goals. To achieve this, CARB staff propose to enhance the current targets that consider statutory, technological, and other policy factors that have changed since 2018, when the targets were last adopted (e.g., progress made to implement SCSs, new funding programs, updated regulatory efforts, and new research).
