The California Department of Transportation (Caltrans) proposes to replace the Traffic Management Systems (TMS) elements at three locations along I-5 at Postmiles (PM) R13.2, R13.7, and R14.0 in San Joaquin County. The scope of work includes replacing existing cabinets and controllers at all three locations. All work will be done within Caltrans Right of Way. The purpose of the project is to ensure the Traffic Management Center has reliable real-time live video feed of roadway, traffic, and weather conditions within the project limits. The project is needed to improve mobility of the traveling public.



#### **General**

- Environmental reevaluation will be required if the scope of the project changes to include additional areas or activities, or if previously unknown cultural or other sensitive resources are discovered. Contact Environmental Office if project changes occur or sensitive resources discovered.

#### **Cultural**

- If cultural resources are discovered at the job site, do not disturb the resources and immediately:

1. Stop all work within a 60-foot radius of the discovery
  2. Protect the discovery area
  3. Notify the Engineer
  4. The Department investigates. Do not move cultural materials or take them from the job site. Retain a qualified archeologist to assess the significance of the find. Do not resume work within the discovery area until authorized.
- If human remains are discovered, State Health and Safety Code Section 7050.5 states that further disturbances and activities shall cease in any area or nearby area suspected to overlie remains, and the County Coroner should be contacted. Pursuant to Public Resources Code Section 5097.98, if the remains are thought to be Native American, the coroner will notify the Native American Heritage Commission (NAHC) which will then notify the Most Likely Descendent (MLD). At that time, the landowner will work with the MLD on the respectful treatment and disposition of the remains. Further provisions of PRC 5097.98 are to be followed as applicable.

#### **Hazardous Waste**

- Adhere to standard specifications, section 14-11.15 for handling and disposal of electrical equipment containing materials.
- The Caltrans Standard Special Provision 7-1.02K(6)(j)(iii), which pertains to Earth Material Containing Lead, shall be added to the construction contract. A Lead Compliance Plan prepared by a Certified Industrial Hygienist (CIH) is required and all soil must remain on-site.
