DESCRIPTION OF THE NATURE AND PURPOSE OF PROJECT:

Issue Right of Entry to the Bu Pier Housing LLC for temporary construction staging in a paved area in front of the main entrance to the Malibu Pier for the purpose of lifting construction materials onto a neighboring property’s deck at 23006 Pacific Coast Highway. A 6’ high chain link fence would be placed around the craning zone. A counterweight truck would also be staged in the parking lot. The trucks and crane would be on-site for 1 day. Spotters and security will be on-site to guide people to the temporary access and ensure no access to the craning zone.
