The California Department of Transportation (Caltrans) proposes to construct a project to install a ladder type high visibility pedestrian crosswalk with enhanced signs and Rectangular Rapid Flash Beacon (RRFB) system. The purpose of this project is to improve pedestrian/cyclist mobility at the existing trail crossing of State Route 89 in El Dorado County on Post Mile 26.119. The project is needed to allow safe crossing and reduce exposure.
