The proposed project consists of an 18-lot single-family residential subdivision on approximately 4.2 acres on the northeast corner of 37th Street West and Avenue J-8. The lots would range in size from 8,677 square feet to 10,757 square feet. Access to the subdivision would be provided from 37th Street West and Bogard Court. The streets surrounding the subdivision would remain public.
