### Project Description

Replacement of approximately 5,220 linear feet of galvanized (lead) service lines throughout the city with copper line, from the water meter to the existing main, within the existing public right-of-way. This work would entail replacement at 270 project sites, with an average length of approximately 25 feet.

**Determination**

The City and County of San Francisco decided to carry out or approve the project on June 6, 2024, by a San Francisco Public Utilities Commission administrative approval. This approval became effective following the expiration of the 30-day appeal period on July 15, 2024. 
