Project Title: Van Duzen River Gardens LLC (Project)

Project Location: The Project is located at 2500 Van Duzen Rd in Trinity County, APN 018-090-04-00.

County: Trinity County

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a commercial cannabis Small Mixed-Light Tier 1 license submitted on January 28, 2022, by Van Duzen River Gardens LLC.

Project Activities:

The Project will consist of up to 10000 square feet of mature mixed-light cannabis cultivation. Mature cultivation occurs in five 6' by 53' hoop houses and fourteen 6' by 100' hoop houses. Water is provided by an onsite well, and an onsite septic system serves the site's wastewater needs. Power is provided by solar panels, which are mounted to an onsite shed.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
