In October 2019, your facility, Rueland Electric Co., H. Britton Lees, received Order WQ 2019-0045-DWQ (Order), requiring technical reports to determine the presence of per- and polyfluoroalkyl substances (PFAS) at chrome plating facilities. Per the requirements in *Attachment 2* of the Order, you submitted a site investigation workplan, conducted site investigation for assessment of soil for PFAS, submitted the site investigation results in technical reports, dated November 8, 2022, respectively, and uploaded the document, the corresponding analytical sample results, and sample location data into GeoTracker to the satisfaction of the Los Angeles Regional Water Quality Control Board (Los Angeles Water Board).
