The project includes a proposal to develop the subject property with a single-story car wash. The primary car wash structure is proposed to be approximately 3,300 square feet in area with a surrounding parking area, new sidewalk, curb ramps, and landscaping. The project also features a vacuum island with seven car ports along the southern section of the parcel. The proposed car wash will operate between the hours of 7:00 a.m. to 7:00 p.m..

The project is proposing grading improvements for noise mitigation and the finish floor of the car wash building will be seven feet lower than the adjacent daycare and two feet lower than Garfield Avenue. An eight-foot-wide landscape planter and eight-foot-tall wall is proposed along the interior property lines adjacent to RD-2 zoned property. The landscaping and wall along the property line shared with the adjacent daycare will be on top of the retaining wall approximately seven feet higher than the car wash building. The proposed project is also conditioned to install frontage improvements to both Garfield Avenue and Verner Avenue consisting of curb, gutter, sidewalk, and landscaping.
