Project Title: Summit Green, LLC (Project)

Project Location: The Project is located at 351 B Bar K Ranch Road (Accessor's Parcel Number 015-070-68-00) in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Mixed-Light Tier 1 commercial cannabis license.

Project Activities: The project is located in the unincorporated portion of Douglas City in Trinity County. The project site is zoned A10 and will consist of 9,968 ft² of mixed-light cannabis cultivation and cannabis support areas totaling 3,702 ft². Water for the project is provided from a diversion in Browns Creek. An on-site septic system serves the project's domestic wastewater needs. Access to the project site is via B Bar K Road, which is a paved, county-maintained road.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
