Project Title: Gold Mountain Farms (Project)

Project Location: The Project is located at 021-020-012-000 in Calaveras County.

County: Calaveras County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Outdoor commercial cannabis license.

Project Activities: The Project will consist of legacy outdoor cultivation area, existing onsite metal building, the existing onsite metal storage container, and a groundwater well. Seventeen 6-foot-wide outdoor canopy areas of various lengths will be established within the legacy outdoor cultivation area, for a total combined / aggregate canopy of 9,996 sq ft. The existing onsite metal building will be used for cannabis drying and harvest storage. The existing onsite metal storage container will be used for pesticides and agricultural chemicals storage. A secure Cannabis Waste Storage Area will be established directly adjacent to the legacy / proposed outdoor cultivation area.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. Calaveras County Board of Supervisors certified an Environmental Impact Report (EIR) for the Medical Cannabis Cultivation and Commerce Ordinance Project in January 2018. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
