Project Title: BJM Systems Llc (Project)

Project Location: The Project is located at 14197 FS Rad, Ruth, CA 95526 in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Mixed-Light Tier 1 commercial cannabis license.

Project Activities: The Project will consist of the continued cultivation of 9,735.5 square feet (sf) of Tier 1 mature mixed-light cannabis consisting of six (6) greenhouses (2-20'x150' and 4-20'x96') and two (2) 6ft 10'x86' hoop houses and 9,548 square feet of existing support infrastructure. Water for the project would be provided from an existing permitted groundwater well, and power would be provided by gasoline generators.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
