The proposed Project involves City approval of a Specific Plan Amendment, Tentative Parcel Map, Development Plan Reviews, and Conditional Use Permits to allow the construction and operation of a self-storage facility, two sit-down restaurants, six fast-food restaurants, two gas stations including convenience stores, and a car wash. In total, the project proposes 126,342 square feet of commercial building space on 20.28 acres.
