Reasons why project is exempt:

Section 15301 Existing Facilities (Class 1): The Class 1 Categorical Exemption consists of the operation, repair, maintenance, permitting, leasing, or minor alteration of existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of existing or former use. Based on bids received, the Port would enter into contracts with contractors to perform the repair, rehabilitation, and/or replacement of existing Port-wide waterfront concrete structures under the existing five-year Harbor Development Permit (HDP) 23-036 issued in August 2023 for five-year maintenance dredging and routine maintenance of in-water structures. The project involves negligible or no expansion of existing or former use.

Section 15302 Replacement or Reconstruction (Class 2): The Class 2 Categorical Exemption consists of the replacement or reconstruction of existing structures and facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced. Based on the bids received, the Port would enter into contracts with contractors for work involving the repair, rehabilitation, and/or replacement of Port-wide waterfront concrete structures under the existing HDP 23-036 issued in August 2023 for five-year maintenance dredging and routine maintenance of in-water structures.
