Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis Retail License submitted on 12/28/2017 by Cory Azzalino.

Project Activities:

The Project will consist of a cannabis retail and non-storefront retail facility located at 1625 E Gertrude Place, Santa Ana, CA 92705. The APN is 403-081-04. It will operate out of an existing 7209 SF building on a lot size of 19,570 SF. The zoning is light industrial. There will be approximately 60 delivery drivers and 10 retail employees on varying shifts throughout the day. There are roughly 12-14 employees on site per any given shift. The business estimates approximately 20-21 deliveries an hour.

This class is not intended for projects that would result in any significant traffic, noise, air quality, or water quality impacts. This exemption is not limited to any use type and may apply to residential, commercial, industrial, public facility, and/or mixed-use projects. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
