The City of Los Altos is proposing to replace the existing Adobe Creek Sewer Main which includes 53 sewer lines, totaling 6,580 linear feet. The project site is located largely within private properties, the City's public right-of-way, and various parks. The existing sewer main is at capacity and a previously installed cured in-place pipeline is failing. The existing pipes are in a state of disrepair which allows for infiltration during the wet season, as well as blockages that lead to sewer overflows and spills. The purpose of the proposed project would increase resiliency and longevity of the sewer main and would greatly reduce maintenance needs associated with sewer line repair.
