Project Description:	Plan No. 22-00011; Vesting Tentative Tract Map (TTM No. 20484) to subdivide Approximately 43.0 acres into 131 lots for single-family detached residential development. The project also includes 10 lettered lots for storm drainage and recreational facilities.
