Project Title: Streambed Alteration Agreement No. 1600-2021-0018-R2 (Rattlesnake Timber Harvesting Plan 4-21-00053-AMA, Sierra Pacific Industries)

Project Location: The projects are located within the boundaries of a timber harvesting plan in Amador County, within CALWATER watershed Rattlesnake Creek and its connecting tributaries; Township 8N, Range 15E, Section 24 of the U.S. Geological Survey (USGS) 7.5-minute Peddler Hill, Mount Diablo Base and Meridian.

Project: The project is limited to installing a temporary log Spittler crossing. Further explanation of work can be referenced within the THP 4-21-00053-AMA.
