Project Description: The proposed project consists of installing French drains, trench drains, and a catch basin at 4S Ranch Sports Park. The proposed project would also include the removal and replacement of DG to improve the area.

This is to advise that the County of San Diego Director of Department of General Services has approved the above described project on **August 7, 2024** and found the project to be exempt from the CEQA under the following criteria:

Statement of reasons why project is exempt: Section 15301 (Existing Facilities) is applicable because the proposed project includes minor alterations to the landscape such as installing French drains, trench drains, and a catch basin to help with drainage issues and repairs to areas with eroded DG at the 4S Ranch Sports Park. Section 15304 (Minor Alterations to Land) is applicable because the proposed project includes ground disturbing activities which does not involve the removal of healthy, mature, scenic trees.

Additionally, the project would not impact environmental resources of hazardous or critical concern that are designated, precisely mapped and officially adopted by government agencies; does not contribute to cumulative environmental impact; would not have a significant impact on the environment due to unusual circumstances; does not damage scenic resources within a designated state scenic highway; is not on the list of Hazardous Waste and Substance Sites pursuant to Section 65962.5 of the Government Code; and does not cause adverse change in the significance of a historical resource.
