NOTICE OF EXEMPTION FROM CALIFORNIA ENVIRONMENTAL QUALITY ACT

LEAD AGENCY: East Bay Regional Park District (EBRPD)

PROJECT TITLE: Pinole Shores Landslide Repair

PROJECT LOCATION: San Francisco Bay Trail, Contra Costa County

PROJECT APPLICANT: EBRPD, 2950 Peralta Oaks Court, Oakland, CA 94605

PROJECT DESCRIPTION: The purpose of the project is to make repairs to 120' of SF Bay Trail that was damaged by a landslide in winter 2022-23. The project will use a soldier pile retaining wall to fortify the trail area from the adjacent hillside and V-ditch. The project does not occur within any jurisdictional waters.

DETERMINATION: EBRPD has reviewed the project and determined it to be categorically exempt from the California Environmental Quality Act (CEQA) pursuant to the following exemptions:

- a. **14 CCR Section 15301 – Existing Facilities.** The project consists of the repair, maintenance, and minor alteration of existing structures, facilities, or topographic features, involving negligible or no expansion of use resulting from the implementation of this project.
- b. **14 CCR Section 15302 – Replacement or Reconstruction.** The project consists of replacement of existing structures and facilities and the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced, including but not limited to replacement or reconstruction of existing utility systems and/or facilities involving negligible or no expansion of capacity.
- c. **14 CCR Section 15304 – Minor Alteration to Land.** The project consists of minor public alterations in the condition of land, water, and vegetation which do not involve removal of healthy, mature, scenic trees.
