**NOTICE OF INTENT TO ADOPT AN INITIAL STUDY/MITIGATED  
NEGATIVE DECLARATION FOR ADMINISTRATIVE PERMIT No.  
AA22-056 ("100 TOWER ROAD 200 MW BATTERY ENERGY  
STORAGE SYSTEM PROJECT")**

**NOTICE IS HEREBY GIVEN** that the County of Merced intent to adopt a Mitigated Negative Declaration (MND) and supporting Initial Study (IS) for Administrative Permit No. AA22-056 ("100 Tower Road 200 MW Battery Energy Storage System Project"), described below, prepared in accordance with the California Environmental Quality Act (CEQA).

**PROJECT DESCRIPTION & LOCATION:** The project is a request to establish, construct, and operate a battery energy storage system (BESS) adjacent to the existing PG&E Wilson substation for an expected operational period of 30 years. The project involves installation of approximately 315 containers with approximately 40 battery modules each and interconnection equipment. The project site is located on the east side of North Tower Road, approximately 450 feet north of East Childs Avenue in the Merced area, identified as Assessor's Parcel Number (APN) 061-033-018. The project site is designated Agricultural land use in the General Plan and is zoned A-1 (General Agricultural).

**PUBLIC REVIEW & COMMENTS:** August 16, 2024 to September 20, 2024

The original comment period for this recirculated notice was began August 16, 2024 and was to end on September 16, 2024, and is now being extended for four days. The IS/MND is being circulated for a 30-day public review and comment period. Any written comments on the IS/MND must be received at the above address or above email no later than 5:00 PM on the end date of the public review period.
