Project Location: The Project is located at 500 N Union Ridge Rd in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Outdoor commercial cannabis license.

Project Activities: The Project will consist of cultivation of a combined cultivation area of 19,000 square feet (10,000 sq. ft. of mature cultivation area and 9,000 sq. ft. of immature growth). Proposed infrastructure includes: four (4) temporary hoop houses/permanent greenhouses 30'x100' (2,500 sq. ft. canopy each) for mature, three (3) temporary hoop house/permanent greenhouses for immature cultivation, and one (1) 8' x 40' container for packaging and processing, harvest storage, waste storage and administration hold area. Water is supplied by a permitted groundwater well and pump that is currently installed on the property, with three to five water storage tanks to be installed. The property will utilize a permitted septic system serviced routinely as needed.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
