Project Title: Chinquapin Ridge LLC (Project)

Project Location: The Project is located at 1651 FS Road 7N 23, Salyer, CA 95563 in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Mixed-Light Tier 1 commercial cannabis license.

Project Activities: The project includes the cultivation of approximately 10,000 square feet of mature canopy in twelve (12) hoop houses of varying sizes: 8'x64', 8'x71', 8'x76', 8'x86', two (2) 8'x89', 8'x94', 8'x96', two (2) 8'x97', and two (2) 8'x100', and 201-100-gallon pots. There is currently existing infrastructure for project support. Water for the project would be provided from a permitted groundwater well and a permitted septic system would serve the Project's wastewater needs.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
