Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a commercial cannabis Small Indoor license submitted on 05/20/2022 by Green Edgewater LLC.

Project Activities:

The project is located at 7700 Edgewater Dr #C Suite 529 & 670, Oakland (APN 042-4435-001-11) in Alameda County. Operations will consist of an indoor cannabis cultivation operation within an existing +/- 50,000 square foot (sf) commercial building on a 10.6-acre lot. The project includes 5467 sf of mature canopy and 932 sf of immature canopy. Associated functions include pesticide and agricultural chemical storage area, processing area, harvest storage area and cannabis waste area. No expansion of the building is planned.
