Caltrans proposes to maintain and improve the surface life of the pavement on State Route (SR 78) in Imperial County Near Octillo Wells from Postmile 0.0 to 13.17 starting at the San Diego County Line Road to SR 86 by micro-surfacing over the existing pavement, placing rumble strips, and restriping. Environmental conditions are listed in the project Environmental Commitments Record (ECR).
