The project is located from post mile 25.7 to post mile 34.4, on Highway 1 in and around Morro Bay and Cayucos, in San Luis Obispo County. Project work will include but is not limited to the following: grinding and overlaying pavement, upgrading lighting, replacing some sidewalk, replacing/ modifying/ adding curb ramps that will be ADA compliant, updating guardrail (including post replacement), replacing median thrie beam, replacing signal detection loops in pavement, widening right turn pockets to add bike lanes at three intersections, and replacing approximately 17 signs (post and panels). Roadway improvement details will continue to be worked out as the project progresses.
