The Agreement would allow the City to issue Hur Flooring Co. a "Notice to Proceed", initiating the process to commence the gym floor replacement and repair.</p> |

| <p>Reason why action was exempt:</p> | <p>The Agreement is categorically exempt from the California Environmental Quality Act ("CEQA") pursuant to State CEQA Guidelines Section 15302, Replacement or Reconstruction ("Class 2"). The Class 2 exemption allows for the replacement or reconstruction of existing structures or facilities where the new structure will be located on the same site as the structure replaced and will have substantially the same purpose and capacity as the structure replaced.</p> <p>Here, the Project involves replacing the existing Rudy Hernandez gym flooring with new resilient, first-grade maple flooring, proving the community access to improved gym facilities.</p> <p>None of the "exceptions" to the categorical exemptions apply under State CEQA guidelines § 15300.2.</p> |
