Project Title: Permit No. 19876 Broadband Network Infrastructure Project –State Route (SR) 70 at Feather River Bridge No. 12-0141R at PM 14.83

Project Applicant (if any): California Department of Technology

Project Location/Address/City/County: The project is located on State Route 70, approximately at 39.51168°N, 121.57247°W, crossing Bridge No. 12-0141R, in the City of Oroville, Butte County.

Description of Nature, Purpose, and Beneficiaries of Project: To install one, 2-inch diameter Fiber Optic Conduit (FOC) housing fiber optic cables crossing the Feather River Bridge (#12-0141R, authorized under Board Permit No. 3567) at Postmile 14.83 on the Eastbound (upstream of the bridge), on State Route 70. The FOC is proposed to be installed on each end of the bridge and will be attached to the bridge on the eastbound (upstream) right overhang.

Reasons Why Project is Exempt:

The project is statutorily exempt under the provisions of CEQA. The Board’s approval involves issuing an encroachment permit for the installation of a Broadband Network Infrastructure which is exempt under the statutory exemption of the CEQA Public Resources Code Section 21080.51.

In addition, the Board has determined that the project is exempt from CEQA under the Class 3, New Construction or Conversion of Small Structures categorical exemption (CEQA CCR, Title 14, Section 15303), because the activity consists of the installation of utility extensions. The project is also exempt under the Class 4, Minor Alterations to Land categorical exemption (CEQA CCR, Title 14, Section 15304), because the project involves minor public alterations in the condition of the land which does not involve the removal of healthy, mature, or scenic trees. Further, none of the exceptions to the exemption in CEQA CCR, Title 14, Section 15300.2 apply.
