Project Title: Astrid Dobo (Project)

Project Location: The Project is located at 104 Fir Meadow Court, Post Mountain, CA 96041 in Trinity County.

County: Trinity County

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Division 10, Chapter 2, Section 26012, approved a Small Outdoor commercial cannabis license.

Project Activities: The activity consists of 9,800 square feet of mature cannabis canopy consisting of four (4) 30'x98' metal greenhouses with 25'x98' of canopy space (2,450 square feet) each and the use of existing support infrastructure. An onsite well is used to supply water and an onsite septic system would serve the project's wastewater needs. Power is provided by generators under 50hp with a proposed solar system to be installed.

Reasons Why Project is Exempt: The Department of Cannabis Control has determined that the project is consistent with the local jurisdiction community plan and/or zoning designations. CEQA mandates that the project is consistent with the development density established by existing zoning, community plan, or general plan policies for which an EIR was certified and shall not require additional environmental review, except as might be necessary to examine whether there are project-specific significant effects which are peculiar to the project or its site. The project activity fits within the parameters included in CEQA Guidelines Section 15183 and the activity does not require additional CEQA analysis.
