The project proposes to add five structures with a total of 158 boat slips accommodating boats of various sizes to the existing Pleasure Cove Marina. The slip structures would be attached to a floating dock, which in turn would be connected to the shore via a gangway ramp. The slip structures and dock would be held in place by concrete anchors set on the bottom of Lake Berryessa; stainless steel cables would connect the facilities to the anchors.
