Project Description: The California Department of Toxic Substances Control (DTSC), pursuant to authority granted under California Code of Regulations (CCR), Title 22, Division 4.5, Chapter 20, Sec. 66270.61, has issued an Emergency Permit to the World Oil Environmental Services (WOES), (EPA ID# CAD028277036) to store Toxic Substances Control Act classified waste past the ten (10) day storage limit. Specifically, a tank trailer containing approximately 1,160 gallons of used oil contaminated with polychlorinated biphenyl (PCB) will be stored until an authorized hazardous waste treatment, storage, and disposal facility is able to receive the tank trailer. The contaminated used oil is currently being stored at WOES located at 1300 South Santa Fe Avenue, Compton, California.

Background: Upon arriving at World Oil Environmental Services located at 1300 South Santa Fe Avenue, Compton, California, the tank trailer of used oil was evaluated and found to have a PCB concentration greater than 5 parts per million. This classified the used oil as a Toxic Substances Control Act (TSCA) hazardous waste. WOES does not have a permit to manage the TSCA hazardous waste, and an authorized hazardous waste treatment, storage, and disposal facility is not able to receive the waste prior to the ten (10) day storage limit.

<u>Project Activities</u>: The contaminated used oil will be stored in a manner that is protective of the environment by implementing the following controls:

- The tank trailer must remain parked within the secondary containment system under tarps until the tank trailer is transported to an authorized facility.
- To prevent risk to the public, public access is restricted during the storage of the tank trailer.
- Movement and storage of the tank trailer will be in accordance with established standards.

Within ten (10) business days of the expiration of this permit, WOES will submit a final report, signed in accordance with Title 22, CCR Sec. 66270.11(d). The report shall include certification that the storage area has been cleared of all residual hazardous waste generated from this emergency treatment and all generated waste has been properly managed. The Emergency Permit is effective beginning August 28, 2024 and shall expire on September 30, 2024.
