Austal USA is a U.S. Government and commercial contractor that specializes in repair and maintenance of ships for the U.S. Department of the Navy, other governmental entities, and commercial customers. The objective of the proposed project is to add a new floating dry dock (FDD) to support operations at a location adjacent to the Naval Base San Diego. The FDD has two emergency power generators, a control house, a lavatory, two cranes, and fixed lighting. The proposed project includes the construction of a wharf, mooring dolphin piers and the drydock emplacement.
