Project Location: The Project is located at 2943 DAYLIGHT WAY CA, 95111, in SANTA CLARA COUNTY.

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Microbusiness cannabis license submitted on 6/10/2020, by UL SAN JOSE LLC.

Project Activities:

The Project will consist of a microbusiness cannabis facility that will engage in cannabis retail, distribution, and nursery activities. The project will occupy an existing 23,500square foot structure that is sufficiently served by required utilities and public services.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 and Class 32 Categorical Exemption project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. Class 32 consists of projects characterized as in-fill development meeting the conditions described in this section. The project is consistent with the applicable general plan designation and all applicable general plan policies as well as with applicable zoning designation and regulations. The proposed development occurs within city limits on a project site of no more than five acres substantially surrounded by urban uses. The project site has no value as habitat for endangered, rare or threatened species. Approval of the project would not result in any significant effects relating to traffic, noise, air quality, or water quality. The site can be adequately served by all required utilities and public services. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
