California Department of Transportation (Caltrans) proposes to rehabilitate pavement in Butte County on Route 32 from PM R23.9 to PM 30.8 and from PM 31.0 to PM 31.6. Scope of work includes AC pavement repair, AC overlay, AC dike replacement, fog seal application, traffic safety systems upgrade, and placing shoulder backing. The project will occur within Caltrans right of way.

Purpose: The purpose of this proposed project is to preserve and extend the service life of existing pavement in Butte County on Route 32.

Need: These low-cost improvements that will aid in public safety are needed to prevent further pavement deterioration.
