Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a commercial cannabis Specialty Indoor license submitted on 01/03/2020 by JBTB Holdings, Inc.

Project Activities:

The project is located at 1031 98th Ave, Oakland (APN 044-4989-10-4) in Alameda County. Operations will consist of a cannabis cultivation within an existing 7,663 square foot (sf) commercial building on a 45,100 sf lot. The project includes 2304 sf of mature canopy and 690 sf of immature canopy. Associated functions include pesticide and agricultural chemical storage area, processing area, harvest storage area and cannabis waste area. No expansion of the building is planned.
