The Harbor Industrial Area (HIA) Specific Plan covers a 62-acre area located east of Old County Road and west of Hwy 101, directly abutting the southern Belmont city limits. The City of Belmont is developing the HIA Specific Plan to guide anticipated growth and development in this district to best serve the community and facilitate a thriving economy. The HIA Specific Plan's proposed land use designations would allow commercial, industrial, office, life science, and residential uses. An existing mobile home park would be retained. Maximum building heights within the HIA Specific Plan area would be limited by the Comprehensive Airport Land Use Compatibility Plan for the Environs of San Carlos Airport (ALUCP), which dictates the maximum height permitted within the HIA Specific Plan to protect navigable airspace around the airport. The HIA Plan area would be built out over an approximate 25-year period.
