Project Location: The Project is located at 68816 Summit Dr, Cathedral City, CA 92234 in Riverside County.

County: Riverside

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code Division 10, Chapter 2, Section 26012, approved a Cannabis microbusiness License submitted on 01/27/2022 by Vahe Martirosyan.

Project Activities:

The Project will operate a cannabis microbusiness with cultivation, distribution, and type 6 manufacturing located at 68816 Summit Dr, Cathedral City, CA 92234. The APN is 687-161-015. It will operate out of an existing 11,356 SF building on a lot area of approximately 18,295 SF. It will be comprised of 480 square feet of manufacturing, 850 square feet of distribution, 5,281 square feet of cultivation, 1,168 square feet of indoor parking, and 3,577 square feet of office, storage, lounge, restrooms, and other ancillary space. The surrounding uses include retail and commercial service uses, a concrete plant and other cannabis businesses.

Reasons Why Project is Exempt:

The Department of Cannabis Control has determined that the project is a Class 1 Categorical Exemption Project. Class 1 Categorical Exemptions consist of the operation, repair, maintenance, permitting, leasing, licensing, or minor alterations to existing public or private structures, facilities, mechanical equipment, or topographical features, involving negligible or no expansion of use beyond that existing at the time of the lead agency's determination. The Project involves the use of an existing industrial building with no proposal for building expansion. The design, location, size, and operating characteristics of the Project are compatible with the existing and future land uses within the vicinity as it is zoned light industrial zoned. None of the exceptions to the exemption defined in Section 15300.2 apply to the Project.
