Entitlements for a 89,312 square foot mixed-use development comprised of 62 multi-family residential units (10 affordable for-rent units and 52 market rate for-sale units) and 3,339 square feet of ground floor commercial space at the corner of Jibboom Street and High Street in Downtown Truckee. Submitted pursuant to SB 330 and approval of a 50% density bonus. Beneficiaries are the applicant, Town and future residents and businesses.

Reasons why project is exempt:

The project is consistent with the 2040 General Plan, Downtown Plan and Development Code with approval of the waivers requested pursuant to State Density Bonus Law. The project site is less than 5 acres, in the Town of Truckee. The site does not have value for habitat because it is a rough graded site in an urban area of Downtown Truckee. Technical studies submitted did not identify impacts to air quality and noise, and the project is exempt from transportation analysis. Compliance with conditions of approval will ensure there are no impacts to water quality. All utility providers have reviewed the project and none have objected to serving the project.


