Project Location: The Project is located at 2792 Mandela Parkway, Oakland (APN 7-585-1-4) in Alameda County

Project Description:

The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a commercial cannabis Small Indoor license submitted on 11/05/2019 by Good and Baked, Inc.

Project Activities:

The project is located at 2792 Mandela Parkway, Oakland (APN 7-585-1-4) in Alameda County. Operations will consist of a cannabis cultivation within an existing commercial building on an approximately 55,000 sf lot. The project consists of 8009 sf of mature cannabis canopy and 544 square feet of immature canopy. Associated functions include pesticide and agricultural chemical storage area, harvest storage area, processing area, packaging area and cannabis waste area. No expansion of the building is planned.
