

RESOLUTION OF THE BOARD OF EDUCATION OF THE
CORONA-NORCO UNIFIED SCHOOL DISTRICT
ADOPTING NOTICE OF EXEMPTION FOR VICTRESS BOWER
CLASSROOM ADDITION

WHEREAS, the Corona-Norco Unified School District (“District”) owns and operates Victress Bower School for Exceptional Students, located at 1250 Parkridge Ave., Corona, CA 92880 (“School”);

WHEREAS, on April 16, 2024, the District’s governing board (“Board”) awarded a public works contract pursuant to California Education Code section 17406 for the Victress Bower School Classroom Addition Project (“Project”);

WHEREAS, the Board has determined that the Project is categorically exempt from the provisions of the California Environmental Quality Act of 1974, as amended, pursuant to Title 14, sections 15301, 15303, 15304, 15311, and 15314 of the California Code of Regulations, as the Project consists of minor improvements of an existing structure, including but not limited to (a) new modular building and associated site work on the existing Victress Bower School campus.

NOW, THEREFORE, the Board of Education of the Corona-Norco Unified School District does hereby resolve, determine, and order as follows:


Section 1. The Notice of Exemption attached hereto as Exhibit “A” and incorporated herein by this reference is adopted.

Section 2. The Superintendent or his designee is hereby authorized and directed to cause the Notice of Exemption to be executed and timely filed with the Assessor-County Clerk-Recorder for Riverside County.


