The proposed Project is the establishment of General Waste Discharge Requirements (GWDRs) for Commercial Lily Bulb Operations to control discharges of agricultural pollutants to surface water and groundwater originating from lily bulb farming activities in the Smith River Plain. Lily bulb operations have the potential to discharge pollutants to surface water and groundwater from stormwater and irrigation runoff, the application of pesticides and fertilizer, erosion of sediment, and removal and suppression of riparian vegetation. The proposed WDRs will require Enrollees to assess, plan, and implement a suite of site-specific actions and management practices to control discharges from lily bulb operations.
