Project Title: True Heart Connection, Inc. (Project)

Project Location: The Project is located at 5200 South Fork Rd., Salyer, CA (parcel 008-080-032-000) in Trinity County.

County: Trinity

Project Description: The Department of Cannabis Control, pursuant to authority granted under Business and Profession Code, Section 26012, approved a Medium Outdoor commercial cannabis cultivation license submitted on 4/22/2024 by True Heart Connection, Inc.

Project Activities: The Project will consist of 43,557 square feet of mature cannabis canopy, and 4,500 square feet of immature canopy in greenhouses. Light deprivation techniques will be implemented. The project draws water for irrigation from 2 separate waterbody diversions and an on-site groundwater well. This license is replacing a previously held Mixed-Light License and there will be no artificial lighting implemented for this Project.
