The proposed project is Segment 6 of the IBC Trails Plan. It includes the construction of an approximately 1.35-mile bidirectional multi-use trail along the Barranca Channel between Barranca Parkway and Jamboree Road, designed to meet or exceed Class I, Type A facility standards. Related improvements include installation of lighting, wayfinding signage, safety fencing, crosswalks at street crossings, and Filterra units for storm water treatment.
