The Project proposes to amend the General Plan land use designation for the Project site from General Commercial (GC) to Residential High Density (RH) and change the zone district from Planned Community Commercial (PCC) to Multiple-Family Residential (R3) to permit construction of 204 dwelling units in 12 buildings. The Project will also include a clubhouse and associated residential amenities. The site will include individual garages as well as 127 surface parking spaces and access aisles.


